Matters relating to our application to DTCP for Layout and plot regularization and approval:

Mr. Gopinath team leader of the Coordination team arrived at 5.55 P M and he was requested to brief the members on the present status of our application to DTCP Chengalpet and clarify the points raised by the members.

Mr. Gopinath stated that recently there has been transfer of the key officials in DTCP Chengalpet and also at the head quarters and that the department was fully engaged in clearing the applications for <u>plot regularization</u> received from thousands of plot owners in the layouts located in the various areas under its jurisdiction and that **he would be able to pursue our matter with the new incumbent during the current month and would be in a position to revert in 2-3 weeks from now with regard to "in-principle" approval for layout and the plots of individual applicant members of the association, pending with DTCP**. He also stated that the NOC given by the then Tahsildar, Chengalpet during <u>September 1997</u> for laying Main approach road to the layout from OMR was not accepted by the Dy. Director DTCP who has been transferred recently and instead he wanted to get a fresh certificate from Revenue department stating that there is no encroachment of 'Odai' and Puramboke area within the GP layout vide his letter ref: 3845/2017 dated 31.1.2018 signed by the Dy Director on 5.2.2018 handed over to Mr. Gopinath who in turn delivered the said letter in the core committee review meeting held with him subsequently on 7.2.2018.

In the last review meeting held on 13.4.2018 with Mr.Gopinath by the core committee members, Mr.Gopinath was requested to explain clearly to the new incumbent Dy. Director of the various constraints faced by the association in establishing the exact boundary limits of the layout in the absence of cooperation from the erstwhile Promoters in particular and also come up with an appeal letter from the Association in reply to Dy. Director DTCP, Chengalpet letter dated 31.1.2018 as early as possible.

On Mr.Gopinath's assurance to do his best in the matter, the meeting got adjourned at 6.40 P M.
