Minutes of 8th AGM (virtual) by core members held on 24.10.2020.

Prelude: Due to the existing pandemic and COVID19 lock down restrictions, the customary practice of sending out to the members, the Notice and Agenda of AGM could not be possible. Hence, a virtual meeting of the core committee through video Call was arranged by the Secretary and the following members participated in the meeting:

Agenda, Minutes of the Meeting/Resolutions passed:

The meeting commenced at 4.15 P M and the participants were connected by video calls. The Secretary informed the members of the following items as Agenda, as already explained to each one of the above participants separately:

- 1. To appoint auditors for the year ended 31.3.2020 and recommend the remuneration of the Auditors for the year ended 31.03.2020 as Rs.10000+ applicable GST and placing before the General Body for ratification.
- 2. To adopt the audited accounts and the report of the auditors for the year ended 31.03.2020 and placing before the General Body for ratification.
- 3. To invite Mr. K. Gopinath to the meeting and convey to him of our plan to retain his services to coordinate and follow up with the BLOCK DEVELOPMENT OFFICER (Special) and with any other department/s in the Government with regard to the Association's efforts to have the Patta lands comprised in the roads within the Green Peace Layout gifted to the Panchayat Union which will eventually pave way for obtaining GP Layout regularized.

Resolutions Passed:

- **1.** The appointment of the auditors- M/s. J. Karthik and Co. Chartered Accountants for the year 2019-20 and their remuneration of Rs.10000+ GST were unanimously approved and ratified on behalf of the General Body.
