

Circular to all plot owners in Green Peace Layout, Siruthavoor

**Subject: SURVEY OF PLOTS IN GREEN PEACE LAYOUT, SIRUTHAVOOR REGULARIZED
BY DTCP, TAMIL NADU AS OF END APRIL, 2026 .**

Dear Plot Owners/ Members of the Association,

The main purpose of this Circular is (a) to bring to the notice of all the plot owners, the **legal requirement** to have their plots regularized by Directorate of Town and Country Planning- (DTCP), headquartered in Chennai, (b) to gather an authenticated data relating to the plots already regularized (c) those which are in the process of regularization as of end April, 2026 and (d) to assist/guide the plot owners who need to apply online for registration in the DTCP portal.

Many of you may be aware, that in terms of TN Gazette Order no.TN/MS/No.78 dated 4th May 2017 read with amendment Notification Vide G O no.172 dated 13th Oct 2017 relating to regularization of unapproved /unauthorized plots/layouts in Tamil Nadu, **it is mandatory** for the plot owners in “Green Peace“ layout to get their plots regularized by DTCP.

All plot owners in “Green Peace” layout are strongly advised to peruse the legal aspects and consequences of not getting your plot/s regularized, as downloaded from ‘**Meta AI**’ and **Chat-GPT**, is reproduced as **ANNEXURES for requisite action**.

Members in the association are aware, that the association has **recently obtained approval** for part financing the cost of restoring and strengthening the Main arterial road in the layout with the total length of 3.750 KM under “Namakku Naame Thittam”(NNT) in the first stage and the detailed Work Order is expected to be issued by the TN government to the accredited Contractor post the TN Assembly Election Results slated to be released on 4th May 2026.

This Circular is being sent by email separately to the plot owners who have been in contact with the Association for enrolment as members in the recent past. They are urged in their own interest to fill-in the Survey Form and enroll as members in the association and participate for the common noble cause.

You are requested to fill-in the details in the SURVEY Form appended below and send it back to us by email soonest possible to enable the Association to represent to TN government for their continued support for provision of other basic infrastructure facilities in “Green Peace” layout in the near future such as, side roads in Stage-2 ,Street lights, Drainage, water and sewerage etc.
